Overseas Student Health Cover (OSHC)

The Australian government requires international students and their dependents to have OSHC (Overseas Student Health Cover) while studying in Australia. The recommended provider of OSHC by Sydney Met is AHM and can arrange it when the student pays their tuition fees.
